## ~~Example/Claim Narrative — PerioChip~~

Code 09630 should be used when delivery of a drug and/or medicament is performed separately from scaling and root planing. A narrative should accompany the claim. If a patient receives the drug and/or medicament in conjunction with the scaling and root planing procedures it is not to be identified separately.

Scaling and root planing is performed by a dentist or a periodontist (gum disease specialist). They may use hand instruments called scalers or curettes, similar to those used by hygienists, or they may use ultrasonic tools. The process takes longer and is more invasive than normal teeth cleaning so it may be performed in multiple visits.

Scaling is when your dentist removes all the plaque and tartar (hardened plaque) above and below the gumline, making sure to clean all the way down to the bottom of the pocket. Your dentist will then begin root planing, smoothing out your teeth roots to help your gums reattach to your teeth.
