Marine Security Guard Training - United States Department ...

The minimum length of in-class time for the basic security guard training program is no less than 40 hours. The following table suggests the duration for each training section and includes both in-class and outside class hours. Outside class hours refer to pre-reading only; all other training methods must take place in-class.

Training Curriculum for Security Guards

A certified security guard trainer may appoint an instructor to assist with the implementation of his/her training program by notifying the commissioner of the appointee. Any instructor assisting in the implementation of a training program shall be under the supervision and control of

the certified trainer by which he/she was appointed.

Get a License from the Tennessee Private Protective Services

Pursuant to TAC 35.141 the Level II Training Course and test is required of all* non-commissioned security officers, commissioned security officers and personal protection officers. This training course must be administered by a licensed Level III or Level IV Training School and taught by a licensed Level III or Level IV Instructor.
