At least 300 training hours in not less than 7 weeks and not more than 20 weeks under the supervision of a cosmetology instructor or manicuring instructor certified under Wis. Stat. Â§ 440.63 (3)(am) or a licensed cosmetology manager, in a licensed establishment that is also licensed as a specialty school of manicuring under Wis. Stat. § 440.62 (4)(c).

### Wisconsin Cosmetology License Application - Renewal ...

March 2017 Renewal - Wisconsin Cosmetology CE Wisconsin cosmetologists, cosmetology managers, manicurists, aestheticians, and electrologists with an active license must complete 4 approved CE hours before the March 31, 2017 license renewal. These 4 CE hours must include:

### Approved cosmetology continuing education classes ...

To obtain a cosmetology manager's license, a student must first get a cosmetology license. A cosmetology license is only issued after a student meets the following requirements: Attend a licensed and accredited beauty school and complete the minimum training hours. The state of Washington requires 1500 hours for cosmetology..
